Two Hitachi Condensor Discharge x-ray units procured in 1985-86, with rotating anode x-ray tube, high voltage generators, collimator, and control unit, with 70 mm Odelca camera, control unit, mounting frame, for mounting in a vehicle, suitable for operation in mobile van or as a stationary unit; one in working condition.
  - b. One Meditronics High Frequency 100 mA x-ray unit procured in 2010, with mobile stand, tube head, collimator, control unit, mobile stand, very sparingly used, along with a 70mm Odelca Camera, control unit, mounting frame. Suitable for operation in mobile van or as a stationary unit; in working condition.
  - c. One Siemen Serophos 5 100mA X-Ray Unit procured in 1970 with rotating Anode tube head, collimator, control unit alongwith a 70mm Odelca Camera, mounting frame and lead protective screens in working condition.
